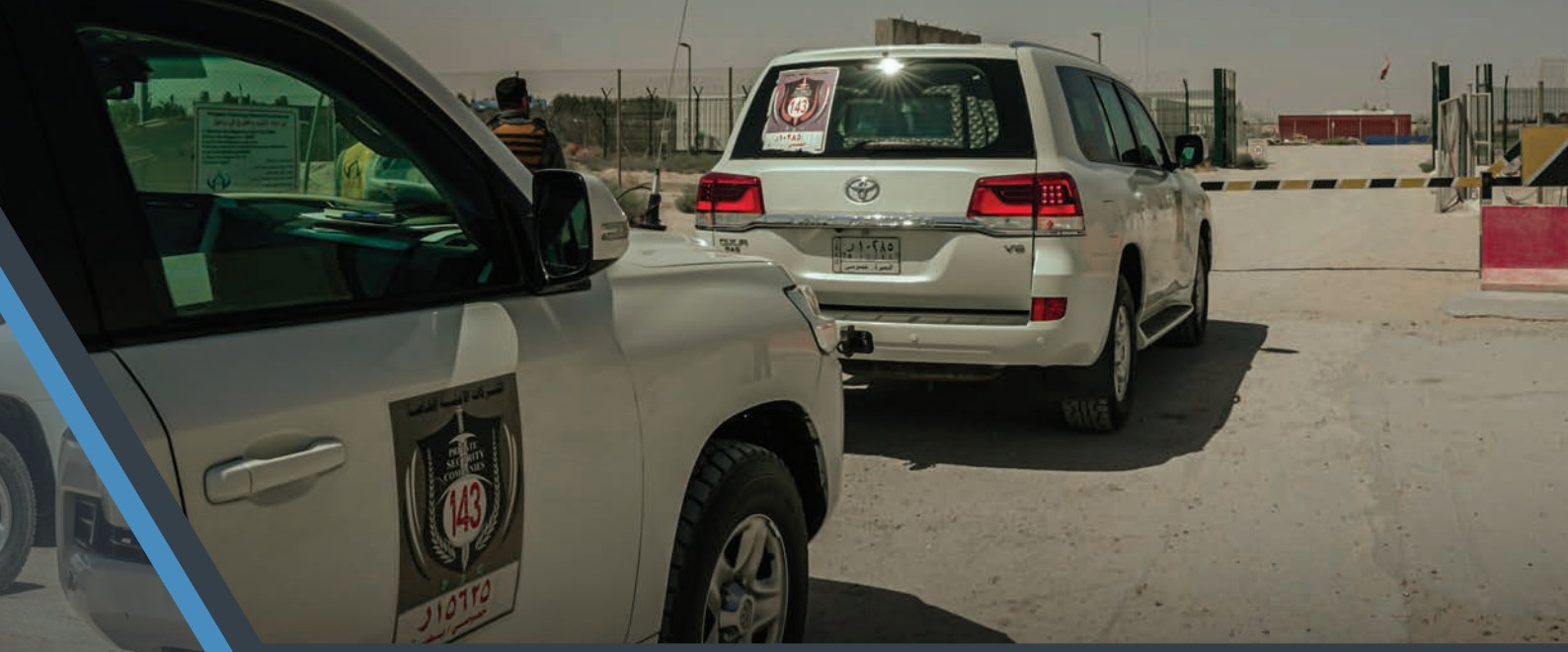

1. We see many of the services we provide much like that of an insurance policy.
